ABOUT HITRUST CSF

The HITRUST Common Security Framework (CSF) was developed in collaboration with healthcare and information security professionals to provide a prescriptive framework to simplify security requirements. It is the most widely-adopted security framework in the U.S. healthcare industry. HITRUST offers a readiness assessment and a validated assessment against the CSF. A validated assessment is conducted by a HITRUST Authorized External Assessor, like BARR, and is the only assessment that produces a validated certification report.

When it comes to HITRUST assessments, **the level of effort each assessment takes directly correlates to the level of assurance it provides.** For example, while the e1 Assessment is low effort, it provides only basic assurance. The r2 Assessment requires significantly more effort, but a higher level of risk assurance.

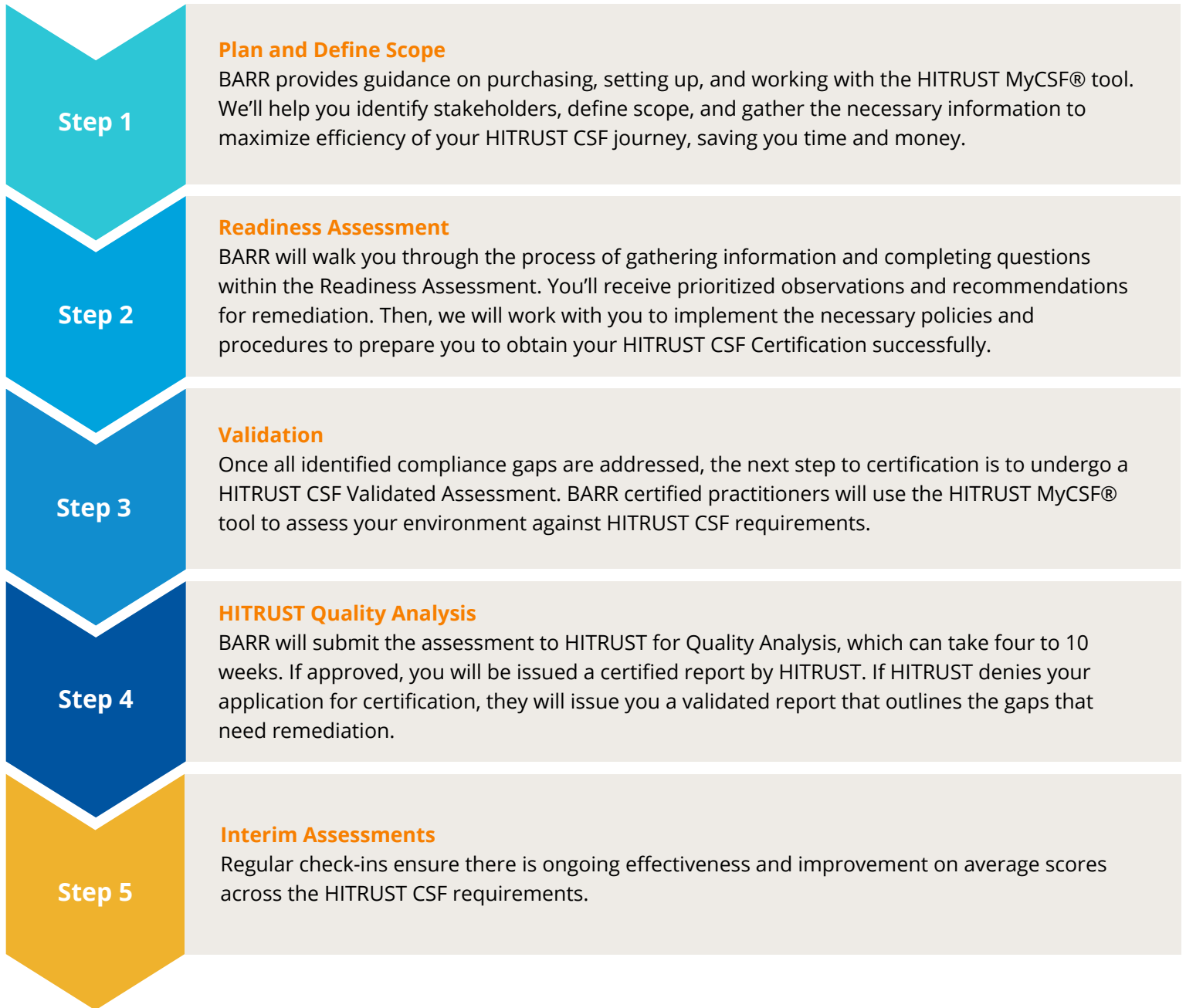
